## High School Enrollment Agreement

You have enrolled in this program for the purpose of preparing for the PSAT, SAT or ACT. All program techniques and materials (online and print) are the exclusive property of The Princeton Review, Inc. (“TPR”/“we”/“us”/“our”). You agree not to disclose, reproduce, sell or distribute to any third party any information, written or spoken, including course materials, obtained from TPR in connection with TPR courses or tutoring programs. You understand that course size is limited and, therefore, enrollment is taken on a first-come, first-served basis.

### Course Cancellation

Please note that TPR may sometimes change course schedules and locations and, occasionally, cancel a course. If we cancel the course in which you have enrolled and are not able to reschedule you into another course that is acceptable to you, we will refund all of the tuition you have paid (including your deposit), and we will have no further liability to you with regard to the cancelled course. You must return to us all program materials that you have received within two weeks of the course cancellation.

### Dismissal from Program

TPR may dismiss you from the program if you have not paid in full by the first session or if you, in TPR’s opinion, are disruptive in the program. TPR will not refund any amounts paid by students who are dismissed from a program.

### Program Payment

You must pay the full tuition by the first session of the program. Students who enroll in a program within ten days of the start of that program must submit payment in full at the time of enrollment. If you have not paid in full by the first session, you authorize TPR to charge the remaining balance to your credit card. If you choose at enrollment to pay the remaining balance by check, you must still provide us with a credit card number on your enrollment form. TPR will charge this card for the balance due in the event that we do not receive your check by the start of the program or if your check is returned for insufficient funds.

### Refunds:

If you choose to cancel your enrollment seven or more days before the first session of your program, we will refund all of the tuition you have paid (including your deposit). If you decide to cancel your enrollment within six days of the first session of your program, we will refund all of the tuition you have paid less your deposit. No refunds will be given after the first session of the program in which you enrolled. You must return to us all program materials that you have received within two weeks of cancelling your enrollment. No refunds will be processed until we have received all of your program materials. Please note that refunds take approximately six weeks to be processed.

### TPR Guarantee
